HIST Executive Committee Meeting, Sunday, August 21, 2022

Hybrid - Fall National Meeting (Chicago, IL) August 21-24, 2022

The meeting started at 5pm CDT.

AGENDA

1) **Welcome and announcements**, Seth Rasmussen Welcomed all to his last Executive Committee (Ex Comm) meeting as chair.

- 2) Secretary-Treasurer's Report, Vera Mainz
 - a) Minutes. Minutes of the Spring 2022 meeting were approved unanimously.
 - b) Election 2022. We have candidates for all offices: Chair-Elect, Sec/Treas, two councilors, two alternate councilors. All current councilors, alternate councilors and the Sec/Treas are willing to run again and Kristine Konkol has agreed to run for Sec/Treas, providing the second candidate required by the HIST Bylaws. Joe Jeffers has agreed to run for chair-elect, but he is concerned about support for travel to national meetings, see item c). The plan is to use https://electionrunner.com/ for the HIST election this fall. This software is well-reviewed and would cost less than \$100 vs. the \$372/year that SurveyMonkey charges.
 - c) Travel Support. There was a discussion of an adjustment in HIST travel support for the Chair and Chair-elect, so both officers can attend both national meetings. A few years ago, we voted to increase the travel support for the program chair to \$1000/meeting as the program chair has to be present at every national meeting. Seth thought we should do the same for chair, and the chair-elect, as it is vital to the health of the division that the chair and chair-elect attend both national meetings. Mary Virginia suggested increasing the support to \$1200/meeting for all three positions because of the rate of inflation: chair, chair-elect, and program chair. Vera noted that the travel funds can be considered to come from the allocation. Given the current level of support, the allocation would support this option. The motion carried unanimously, with two abstaining.
 - d) Membership. Impact of ACS change in member status on HIST membership and response from ACS (emails attached). When Vera was putting together the mailing labels for the second issue of the *Bulletin*, she noted that our membership had dropped from 800 plus members to less than 700, a drop of approximately 100. This change occurred when ACS went to the new model of membership, in April 2022; many members might not have been aware of the consequences of a change of status in their membership. Vera discussed the problem with Carmen and they decided to send the second issue of the *Bulletin* to everyone who received the first issue. Vera then emailed Mark O'Brien at ACS about the effect of the change and basically received a non-answer. The reality is that all divisions are going to be affected by this change, likely resulting in lower numbers for everyone. The real issue is how our membership drop compares to all other divisions. Seth noted that local sections were

- also seeing the problem and was concerned that ACS's response would be to start eliminating/consolidating smaller local sections. In his case, if this happened, the local section would likely end up as the Minneapolis MN local section. The minimum membership option (free) does not allow them to join divisions. It does require at least the next level up membership. Vera suggested she send an email to those who dropped since Dec 2021 and at least ask them to consider rejoining. Vera will also let people know that one possible option is to get a library subscription to the *Bulletin* if they don't want to join ACS at the appropriate membership level. Roger pointed out that this could be a problem, as total membership is part of the formula for the allocation.
- e) <u>Summary of Bulletin expenses</u> for recent issues (attached), led to a discussion of whether dues need to be increased, whether a limited print run should be pursued, or other options for decreasing Bulletin publication expenses (Vera Mainz and Carmen Giunta). Vera noted that HIST membership dues have always been allocated to the Bulletin publication and mailing expenses. The attached summary shows expenses and dues income for 2020, 2021, and 2022 (to date). The trend is clear. The dues are no longer covering the expenses of the Bulletin, mostly due to increased postage expenses, especially for international mail. The increasing difference between expenses and dues need to be addressed. Some questions are: 1) do dues need to be increased and 2) do we investigate having a limited print run or no print run. Vera noted that the dues have not been increased since at least 2005 (latest record she has of the dues). We need to raise the mailing fees for international members to at least cover the costs. Carmen will get that number to Vera prior to any of her communications with the members. Currently dues are \$20 for ACS members in North America plus \$10 if outside NA, and \$25 for non-ACS members in North American plus \$10 for those outside NA. Dan said he was an editor of *Philatelia* Chimica et Physica (the journal of the Chemistry and Physics on Stamps Study Unit (https://www.cpossu.org); John Sharkey (HIST Archivist) has for a long time been the Librarian of the CPOSSU), which has about 150 subscribers. This journal kept the dues the same and without discount offered members the option of getting only the electronic (pdf) version and 50% of the subscribers took the e-copy option, leading to a decrease in costs. He recommended trying the same option for the Bulletin. Art asked if we were considering a dual rate schedule for this option, and Vera said she believed ACS couldn't handle that option. Roger wondered about the optics of increasing the dues. It was noted that one positive with receiving the Bulletin electronically – it makes it a full color journal. We came to agreement on Step 1 - Option of not increasing the dues but sending only electronically. Vera asked permission to send an email questionnaire to members outlining the situation and giving them the option of e-copy only. She will share the draft with the Ex Comm and the final version is attached. As of Nov. 15, 2022, 88 out of 684 members have opted to receive e-copy only. Seth noted that J. Chem. Educ. is planning to go fully open access. Authors will have to bear full costs and this will likely cause fewer submissions from small schools and high schools. He didn't know when the change will occur and noted that many ACS journals have the option of open access. A separate discussion noted that with the current support, was it more expensive to publish 3 smaller issues or 2 larger issues. Carmen said it was more expensive to

- publish 3 smaller issues because of the postage costs. This also means we would not want to routinely publish 3 issues a year.
- f) The HIST funds in the Vanguard Funds are all allocated to the HIST Award Endowment Fund. The return on investment was 10% in 2021, bringing us \$5945.84. See the summary below. The income does not include the HIST symposium support, so if the totals are within \$500, income and expenses essentially balanced. The pandemic did not allow the 2020 Award symposium for Larry Principe to be held in 2020. The event was held as a hybrid event at the Science History Institute (SHI) on October 16, 2021. Gary Patterson organized the event and we thank him for his efforts. The 2021 HIST Award winner, Mary Virginia Orna, chose to have her award symposium at the Spring 2022 National Meeting in San Diego. Mary Virginia chose to use her Award and the remaining funds in previous multiple symposia to support the speaker travel expenses in her award symposium. The 2022 HIST Award winner, Marco Beretta, will have his award symposium at the Fall 2022 National Meeting in Chicago. The stocks donated by Joe Lambert have been transferred to the HIST Vanguard stock account. We have not cashed them in yet, as Joe recommended we not do so until the price rises to an appropriate level.

g) In a general way HIST is doing well. There is \$109,653.82 in unobligated funds. A summary table of obligated vs. unobligated funds shows an increase of approximately \$46,000 in the obligated funds in 2021 and an increase of approximately \$28,000 in unobligated funds in 2020. In 2020 Jeff Seeman gave a donation to support the CCB Award plus we had an increase of about \$5,000 in the allocation. In 2021, HIST received the extra allocation, plus two IPG awards, totaling \$32,500. In 2022, HIST obligated \$7500 in matching funds for Seth's upcoming workshop in Indy.

- 3) **Report from Program Chair**, Nicolay Tsarevsky (summary attached)
 - a) Update on current and upcoming symposia at national meetings. For Indianapolis, in addition to the HIST Centennial symposium, the Senior Chemists Committee (SCC) is eager to be involved in the Past Presidents symposium for Helen Free but we don't know what they want to do. Mary Virginia will attend the SCC Ex Comm meeting on Monday and she'll see if she if she can get clarification. Her basic point is she doesn't want another division or group to plan another symposium for Helen Free for Indianapolis we should get together and plan together. Also for Indianapolis is Seth's workshop, Gary's HIST centennial symposium and Mary Virginia's symposium on Science in Support of Technical Art History.
 - b) For Spring 2024, there are currently two symposia planned. Art said he wants a full day for his and David's symposium on The Birth of the 3rd Dimension in Chemistry and the Chemical Societies symposium. Nick said we have symposia coming up in regional meetings. If anyone is organizing an HIST session at regional meetings, please let Nick know about it. The ones he knows about are in the newsletter. Nick's will be full day symposium and he has asked for \$1000 in support. Unanimous approval.
 - c) Update on Workshop on Traditional Research Methods in History for Indianapolis (Seth Rasmussen). Everyone he has talked to has been very enthusiastic about the effort. So far, confirmed speakers include Alan Rocke, Brigitte van Tiggelen, Peter Ramberg, David Caruso (SHI), Evan Hepler-Smith (possibly via zoom). There are still pending invitations to Mary Ellen Bowden, Michael Gordin and Larry Principe. The theme of Indianapolis is Crossroads of Chemistry and he has asked the theme organizers to help promote the workshop. He in considering a nominal cosponsorship with CHED.
 - d) Mary Virginia Orna's symposium special funding request (Mary Virginia Orna); This is the Science in the Service of Technical Art History. Most contributors are either very basic ACS members or would not normally be coming to an ACS meeting. The registration is \$500 reg for ½ day symposium. She is asking for \$1000 support for the ½ day because of these costs. Many of those hopefully attending would not be able to afford the registration, let alone the travel. Approved.
- 4) **Report from Councilors**, Mary Virginia Orna and Roger Egolf (see attached)

- a) Mary Virginia Orna The Spring 2022 meeting report is in the newsletter. She is working with the SCC, mostly projects involving networking with younger chemists in YCC to mentor undergraduate students to further their careers. The other project is Great Connection, which is about getting demonstrators into the schools. They've been doing it virtually so far but want to get it into schools with majority populations of underrepresented groups and get volunteers going into those schools.
- b) Roger Egolf- He is serving on M&E and has one more year on M&E. ACS is pushing more and more for seamless hybrid meetings even though a professional society consultant says that hybrid meetings don't work. ACS is pushing very hard to make everything hybrid. This is very expensive, costing about \$50K more per meeting room to have the hybrid capability. Up to the advent of covid, they wanted meetings to pay for themselves and not cost ACS anything. But now they don't seem to care about meeting costs. There is a big push to move the Indianapolis meeting because of social justice issues. Chicago has shuttle service on special roads now to decrease time between downtown and McCormick Center, so some of the bus issues are better. The McCormick Center is also larger, so they can keep the entire meeting in the McCormick Center area. Nick noted that the late posting of the app used for this meeting was unacceptable. Roger said they apologized for the problem. Could Roger bring up the issue of having the program as a pdf and have the ability to download the meeting maps.
- 5) **Report from Chair-Elect**, Art Greenberg. He attended Leadership training. He served on the OPA committees that decided the 2018 and 2019 awards (Seth and David). He is co-organizer of the Spring 2024 symposium and have six speakers confirmed so far. This symposium will be a full day and he plans to ask for the standard \$500 per ½ day session once the schedule firms up. When he is chair next year he is considering an opinion poll on *Bulletin* which could be expanded to ask members to submit general papers and organize symposium. He acknowledges that we need to get more younger people involved in HIST. He believes the Rubber and POLY people are interested in some joint symposia. He is considering editing an ACS volume for his symposium. Nick has hopes ACS will change its policy on images with new editor (Beth Campbell).
- 6) **Report from Past Chair**, Dan Rabinovich. This is his last meeting as past chair. SERMACS 2022 will go on with two HIST sessions and 10 speakers. He is running for election on Committee on Committees.

7) Report from the HIST Awards Subcommittee

- a. 2022 HIST Award winner is Marco Beretta. The Jury committee for 2023 (last year of service in parentheses) will be chaired by Seth Rasmussen (2024); members are Mary Virginia Orna (2023), Steve Weininger (2023), and Mary Jo Nye (2023). One more member needs to be appointed, possibly Marco Beretta. Art should formally invite him after this meeting. Art and Seth can discuss members of the 2024 Jury committee, which also need to be finalized. Seth is looking forward to meeting Marco for the first time.
 - The ramifications of the name change for the award to the Joseph B. Lambert HIST Award will be discussed. The plan is to make the name retroactive to the beginning of the HIST Award.
- b. Outstanding Paper Awards Seth Rasmussen. Thanks to Art for helping get the award back on track. The Jury committee for the 2021 and 2022 awards need to be

appointed. The 2018 (Seth Rasmussen) and 2019 (David Lewis) winners have been recently announced. The 2020 jury committee is hard at work and hopes to name the 2020 winner soon. The SOP for the Award (attached) states that "Previous awardees are eligible for additional awards for other publications in the *Bulletin*." This was last affirmed in 2014. The jury committee wanted the Executive Committee to examine the guidelines and decide if it still works or should be changed. Seth believes this is appropriate. Vera agrees that we should continue to recognize the best paper in a three year period. The motion to affirm the current language was approved with one abstention.

- c. CCB Report Vera Mainz (attached). Jeff Seeman told me that his practice is now to make his annual report on the CCB program at the Spring national meeting. The attachment is a list of the 2022 winners and the current financial report.
- d. HIST Fellows Seth Rasmussen (model of certificate attached). Seth put a Call for Nominations in the newsletter and made the deadline for nominations Dec. 31, 2022. Nominations should be returned to the Sec/Treas and not the HIST Awards committee as stated in the newsletter. This will be changed on the HIST website. The nominations will voted on at the Spring meeting. Nick had the Fellow pins, and they and the certificates will be sent to the first class of HIST Fellows, who are being recognized at this meeting. Congratulations to them all!
- e. ACS Fellow Nominations Seth Rasmussen. David Lewis nomination did not succeed. Seth believes they are looking for a lot of service to ACS, not via the local sections or divisions but to ACS, such as councilors. Vera suggested we try for Roger as he has had significant ACS service as councilor and exemplary service. We have tried nominating him twice previously, but it sounds like the criteria have changed. Vera checked with Tom Strom and he said he was never a previous nominator for Roger. She will also check with Gary Patterson to see if he previously nominated Roger. Mary Virginia recommends we ask nominators to send a copy of their material to Vera in order to keep a record of it.

8) **Report from Archivist**, John Sharkey

- a) The archives for the Division of the History of Chemistry are housed in the Science History Institute in Philadelphia. As the SHI has not been open on a regular basis, the most recent HIST archives have been stored in my house. However, John recently deposited three years of archives at SHI and the archives are now up to date through 2021.
- b) The archives are open to researchers by making a reservation through the Othmer Library at SHI. The archives now consist of 54 boxes of archival material. - c) We are always looking for material for the archives. As you consider disposing of your historical collections please think of items that may of historical interest for the HIST archives. If you have presented a paper at HIST we would very much like to add a copy to the archives. All we need is a digital copy of the paper

(or even a digital scan) and when the paper was presented. All rights to the paper remain with the author. Please send an email to <u>johnbsharkey@me.com</u> if you have any questions.

- 9) **Report from Bulletin Editor**, Carmen Giunta. The funding and distribution model was discussed, see 2e), above. All submissions are in for the Mary Virginia Orna HIST Award issue. He has received a spate of submissions from the Rayner-Canhams, Istvan Hargittai, and others, in the last month. Make sure we can pay for printing.
- 10) **Report from Historian**, Gary Patterson. Gary is continuing to work on HIST Centennial projects.
- 11) **Report from the Alternate Councilors,** Christopher Heth, David Lewis, plus Nicolay Tsarevsky
 - a. MPPG Meeting Themes Update

12) OLD BUSINESS:

- a) Marie Daly video Mary Virginia Orna. Mary Virginia requested support for a Marie Daly video. Marie Daly was the first African American female to receive a PhD in chemistry in the US and will be honored with a National Historic Chemical Landmark in the New York Local Section next spring in New York. She requested \$5000. After discussion, we approved \$2500 to serve as seed money. The hope is that the other \$2500 can be raised from the Chemistry Dept. at Columbia University, where Daly received her degree, or from an IPG or other source.
- b) Strategic planning and IPG proposal Seth Rasmussen. Art, Vera and Seth discussed strategic planning off-line. One question we had was whether we have to use ACS facilitators or find some of our own. Seth found we did not have to use an ACS facilitator, but the facilitator is ¼ of the scoring so we'd have to know exactly who for an IPG proposal. An alternative might be a HIST retreat at SHI with someone like Alan Rocke or Nathan Brooks to serve as facilitators, someone who could help HIST become a better history organization and not necessarily a better ACS organization. Seth is willing to write the IPG. Roger participated in strategic planning session for his local section, he felt it was rushed and felt like the attendees were just throwing ideas against the wall. He also felt that the goals were not evaluated in terms of what could actually be accomplished. HIST's last strategic planning session was in 2008, so some type of focused discussion on the next 5 year goals and the strategies to achieve them would be useful. There was a consensus that a retreat with a specific focus would be better for HIST. Seth will start working on this and send emails out to the Ex Comm as input is required.
- c) Art felt website is excellent. Art gave a talk on pottery and wondered if there was a process to put a link to it on to the website.

13) **NEW BUSINESS:**

a) Mary Virginia has a book signing Tuesday afternoon, between 3-4pm, for her new book, "March of the Pigments," during the Expo at the Royal Society of Chemistry booth 263.

The meeting ended at 7pm.

Dear Vera, Thanks for reaching out. I would like to provide some additional background regarding the member termination process and the changes you are seeing in your roster.

As you're aware, ACS has rolled out a change to our termination process effective April 1. On that date and moving ahead, members who do not renew their membership are being transitioned into the new Community Associate category 60 days after their payment was due. The Community Associate category does not provide "Member" status and does not include the right to vote. It does, however, provide a vastly improved and streamlined experience for restoring a small handful of benefits for these individuals, and provides ACS a means to keep in contact for much longer. We have a simplified upgrade process that lets them self-serve to reactivate their memberships and receive a complete 12-month term.

Attached is a copy of the HIST Activity Roster for April which include the bulk of members that were impacted by this change. The members that were shifted to associate status were not active, not in good standing, and on their way to termination so this swap allows us to maintain contact with them moving forward. This larger than usual drop is unique from transitioning all of those members that had lapsed from April 2021 until January 2022. Moving ahead, all monthly changes will revert to normal levels. We remain in contact these individuals as they remain in the ACS ecosystem as Community Associates. As such, they receive weekly newsletters which include information on upgrading and details on each ACS division. Our messaging also explains they may still be divisional affiliates should they choose.

All ACS divisions were similarly affected by the new member termination process. With the launch of the new membership packages and the opportunities this provides, we have a been communicating with the volunteer leaders of our component groups to further explain the membership changes, impacts, and status in depth and respond to any and all additional questions. You and the other leaders of the HIST should have received messages from ACS governance/staff about this change prior through emails and newsletters. You may consider viewing a recording of one of our **Town Hall meetings** and visiting our **FAQ** for additional details. Should you have additional question, I would be happy to arrange a meeting (virtual or at the Chicago National Meeting).

Hello,

I am the Sec/Treas of the HIST Division. The ACS went to the new membership model starting with the April roster – from the latest notification of the availability of the June roster:

1. REMINDER: With the 2022 transition to the new ACS membership model, the member termination process has been updated. Effective in April 2022, members who do not pay their dues are automatically moved to the Community Associate category after 60 days of unpaid status. These individuals will be included in the monthly Activity Report. I noted that HIST membership went from an average of 781 "members" (meaning total people listed, not ACS members) to 684, a loss of roughly 100 people. When I compared the Dec 2021 roster and May 2022 roster, I found:

- 1) 597 people were in both rosters;
- 2) 186 people that were in the Dec 2021 roster were not in the May 2022 roster;
- 3) 87 people were in the May 2022 roster that were not in the Dec 2021 roster;
- 4) There were 3 members who died between Dec 2021 and May 2022.

Is this drop happening with other divisions? Are you are tracking this? And did you reach out to those who did not renew divisional memberships under this new model? I ask because I checked with a few of those dropped and a couple of them were recently retired. I had one member who said "In November, 2021 I phoned in my membership renewal. Since I am a retired, fifty-year member there is no membership fee for ACS. But I forgot to mention the HIST Division." He has now renewed, but am I going to have to contact everyone who has dropped or is that something ACS will do? In a targeted way — "You were a member of the XXX Division and you didn't renew your divisional membership. Can you tell us why you decided not to do so?"

Dear HIST Member,

At the last HIST Executive Committee (EC) meeting during the Fall National ACS meeting in Chicago, we discussed the increasing discrepancy between the cost of publishing and printing the Bulletin for the History of Chemistry and the dues collected for members of HIST. The dues collected are earmarked for publication of the Bulletin. The data is shown in detail in the attached spreadsheet and charts. The item marked as 2022-C indicates the Centennial Issue of the Bulletin (47(1)), which was paid for by the extra allocation HIST received from ACS in 2021.

- 1. Mailing costs have increased, particularly for international mail. Further information below.
- 2. Printing costs have increased. Further information below.
- 3. Both these increases indicate the EC must act to bring the budget for the Bulletin (dues collected) into line with the expenses. The first option would be to increase the dues, which have not been increased since 2005 (the last date for which we have information). The second option would be to decrease the number of printed copies produced so as not to go over the budget, without decreasing HIST membership.
- 4. We have decided to try the option of decreasing the number of printed copies by asking all members whether they would voluntarily accept an electronic copy of the Bulletin (pdf) in lieu of a printed copy. This is an OPTION at this point. If enough members accept an electronic copy to balance the budget, we can leave the dues as they are. We will also be increasing the cost of mailing to members outside North America to cover costs unless they opt for electronic delivery.

Thanks to all of you for supporting HIST and the Bulletin.

Details of expenses are shown in the attachments. I have summarized the data below.

1. Mailing costs have increased, particularly for international mail. All mailing costs are dependent upon the weight of the item, which is roughly proportional to the page count and, therefore, the printing cost/copy. The domestic costs have gone up from \$0.59/copy in 2020 to \$1.04 for v47(2). The international costs have gone up from roughly \$7.00/copy in 2020 to roughly \$12.00/copy for v47(2). HIST charges members outside of North America \$10/year extra to cover mailing. It is obvious that this is inadequate to cover costs.

American Chemical Society – Hybrid Council Meeting August 24, 2022 Chicago, IL

Actions of the Council

A. Elections Results – Elected Committees of the Council (CPC)

1. Council Policy Committee

By electronic ballot, the Council elected **Raychelle Burks**, **Anne M. Gaffney**, **Will E. Lynch**, and **Frankie K. Wood-Black** for a three-year term (2023-2025) on the Council Policy Committee (CPC). **Lydia E.M. Hines** was elected to serve through 2023.

2. Committee on Committees (ConC)

By electronic ballot, the Council elected **William F. Carroll, Jr., Ella L. Davis, Carmen Gauthier, Thomas H. Lane**, and **Jason E. Ritchie** for a three-year term (2023-2025) on the Committee on Committees (ConC).

3. Committee on Nominations and Elections

By electronic ballot, the Council elected **Michelle V. Buchanan**, **Alan B. Cooper**, **Kelly M. Elkins**, **Ellene Tratras Contis**, and **Kathryn E. Uhrich** for a three-year term (2023-2025) on the Committee on Nominations and Elections (N&E).

B. Other Council Actions

1. Highlights from Committee Reports and Key Actions

- The Vice Chair of the Council Policy Committee (CPC) reported that both Council meetings in 2023 will be held in a hybrid manner, very similar to what Councilors experienced in Chicago. Councilors celebrating milestone anniversaries were acknowledged and thanked for their years of service on Council.
- The Chair of the Committee on Committees (ConC) recognized those chairs rolling off various committees and thanked them for their service. Newly appointed chairs of committees that report to Council were announced to all Councilors and Councilors were reminded of the new online committee preference form that was open over the summer to solicit names of individuals interested in serving on ACS Society Committees.
- On the recommendation of the Committee on Committees, and with the concurrence of the Council Policy Committee, Council approved the continuation of the Committee on Public Relations and Communications (CPRC).
- On the recommendation of the Committee on Nominations and Elections (N&E), and with the concurrence of the Council Policy Committee, Council approved the Petition to Amend

the Elections Function. This action helps to clarify, consolidate and re-order existing requirements related to nominations and elections.

- On the recommendation of the Committee on Divisional Activities (DAC), and with the concurrence of the Council Policy Committee, Council approved the Petition to Amend the Duties of the Committee on Divisional Activities, providing greater authority to step in and assist Divisions who have inactive Executive Committees.
- On the recommendation of the Committee on Local Section Activities (LSAC), and with the concurrence of the Council Policy Committee, Council approved the Petition for a change in Section Name from the Northeast Tennessee Section to the Tennessee-Virginia Highlands Local Section.
- On the recommendation of the Committee on Membership Affairs (MAC), and with the concurrence of the Council Policy Committee, Council approved the Petition to Amend the Application and Dues Process for Corporation Associates, allowing Corporation Associates to set fees based on a sales revenue model.

2. Council Special Discussion

President Wilson introduced and led a special discussion on "ACS for the Future." She sought Councilor input on positive initiatives, programs or events that would greatly benefit ACS members or ACS at large.

Three specific questions were posed to Councilors for their input and suggestions:

- What can be accomplished to enhance the ACS experience?
- Why (or how) do you think it would make a difference?
- Who would be tasked with leading this effort (e.g. a section, committee, division, or other)?

Councilors provided their ideas and thoughts, and relevant Society units will receive this input within the next several weeks.

C. Resolutions

The Council passed several resolutions:

- In memory of deceased Councilors: N. Bhushan Mandava, Carol Mosher, and Paul V. Smith
- Congratulating Thomas Connelly for his leadership as Chief Executive Officer of the American Chemical Society for the past eight years
- Expressing thanks to the officers and members of the Chicago Local Section as well as to the divisional program chairs and symposium organizers responsible for the outstanding technical sessions
- Acknowledging Angela Wilson's service as ACS President and presiding officer of Council

The fall 2022 meeting was held in a hybrid manner from August 21-25. As of August 24, there were 11,619 registrations (9,355 in-person and 2,264 virtual).

D. HIST Councilors

Mary Virginia Orna is serving as an associate member of the Senior Chemists Committee (SCC). She is on the SCC/YCC Networking Subcommittee and also on the Great

Connections Working Group. She participated in a Strategic Planning Session for the committee at the close of the Chicago national meeting.

Roger Egolf is serving as a member of the Meetings and Expositions Committee (M&E) and its Technical Program Subcommittee. That subcommittee is responsible for advising the ACS meetings staff on the format of national meeting technical programming and the allocation of meeting rooms to the various divisions. Since the COVID pandemic began, M&E has been meeting regularly with the Program Chairs and ACS staff to get updates on the status of upcoming meetings and to make suggestions to ACS staff as they plan the future of ACS national meetings.

GUIDELINES FOR THE OUTSTANDING PAPER AWARD COMMITTEE

To be placed on the HIST website and distributed by the HIST Secretary every year to the Committee members and to HISY's Chair, Chair-Elect, Program Chair, Historian and Archivist

TERMS OF THE OUTSTANDING PAPER AWARD

The Outstanding Paper Award is given annually by the Division of the History of Chemistry at the Fall National Meeting of the ACS and consists of a plaque, a check for \$250, and the right to select books from the current catalog of the *Chemical Heritage Foundation* (or whatever publisher has agreed to be the award co-sponsor) to the extent provided by that co-sponsor. The awardee is selected by the committee from among the papers published in the *Bulletin for the History of Chemistry* for the year of the award and the previous two years. Previous awardees are eligible for additional awards for other publications in the *Bulletin*.

- 1. The Outstanding Paper Award Committee shall consist of three members. An individual appointment is for a period of three calendar years. The terms of the three members are each staggered by a year.
- 2. The outgoing (i.e., current) Chair of HIST makes new appointments effective as of 1 January of the next calendar year.
- 3. The names of the committee members shall be a matter of public record and shall be placed on the HIST website.
- 4. A committee member shall serve as Chair of the committee during the third year of his/her term of appointment.

Responsibilities shall include:

31 January:

- a. The Editor of the *Bulletin of the History of Chemistry* will make available to each committee member a complete set of issues of the *Bulletin* for the three years of award eligibility.
- b. Each committee member will maintain the issues of the *Bulletin* during the period of service and, at the request of the *Bulletin* Editor, either return the issues at the completion of their appointment or forward them on to the next committee member.

31 March: Determination of that year's awardee.

Each committee may determine its own method for selecting the OPA awardee for that year. One recommended process is as follows:

The Editor of the *Bulletin* provides each member with a full set of issues containing the eligible papers. Every member of the committee reads and evaluates all papers that are eligible for the award. The Chair sends a tabulated listing of the eligible papers to each committee member who then ranks the papers, 10 points for their number one choice, 9 points for their number two choice, etc. The votes are tallied, and the highest vote recipient is the awardee. Should there not be an unambiguous awardee, the two or three nominees with the highest point totals are selected for a "short list" and the voting process is repeated. If possible, the entire process is carried out by e-mail.

Other responsibilities are as follows:

- a. **The Chair of the Division** will write the letter of congratulations to the awardee.
- b. The Program Chair will make all arrangements for the Award to be presented as part of the HIST Award Luncheon/Dinner at the Fall National Meeting. As part of these arrangements, the Program Chair will inform the awardee of the time and location of the luncheon/dinner and make the necessary arrangements if the awardee indicates that he or she will attend. The Division covers only the cost of a one-day registration and the luncheon/dinner for the awardee and their guest.
- c. **The Secretary–Treasurer will** make arrangements for the award check and plaque to be made available at the Awards Luncheon/Dinner.
- d. **The Chemical Heritage Foundation or** whatever publisher is willing to be a co-sponsor will make arrangements for the selection of free books. The Secretary-Treasurer will provide the contact information to the awardee.
- e. **The HIST Historian or his/her assignee** will request a photograph and vita of the awardee and will prepare a biography for the HIST website. The HIST Historian or the OPA Chair will communicate an appropriate announcement of the award to the media listed below. The announcement will also be printed in the *Bulletin for the History of Chemistry*.

1 July: The HIST Historian or his/her assignee will arrange for a formal statement of presentation to be read at the Awards Luncheon/Dinner_outlining the reasons for the Committee's selection. The actual presenter may be a member of the

committee or the HIST Archivist/Historian or the Chair or his/her designee. The choice of the presenter should be communicated to the Program Chair. The Chair of the OPA Committee is also responsible for providing the information for the award plaque to HIST's Secretary-Treasurer or HIST's Award Committee Chair and ensuring that it is available for presentation at the Awards Luncheon or is mailed to the awardee.

1 December: The Chair of the OPA Committee will give to the incoming Chair copies of all documents relating to the selection of that year's awardee, including the list of eligible papers, all form letters, information on how to order the award plaque, and a copy of the committee's procedures. The outgoing Chair shall also deposit with the Division Historian all of the materials from the previous year's award which were received from the previous Chair upon assuming office in January.
